

<u>Ham-in-the-Freezer Contest Rules</u> <u>Tune all your Radios to STAR 96.7 FM!!</u>



To enter: Visit the <u>In-Town Giant Food Store on Dorcas Street</u>, and look for the Ham-in-the-Freezer Display, complete the STAR 96.7 Registration Form, write your Weight-of-the-Ham-guess on the back of the form, and deposit the form in the contest box

No entries will be accepted after Wednesday, December 19th, winners will be announced on STAR 96.7 FM on Thursday, December 20th, 2018

- 1. Contestant must be 18 years or older and possess a valid government issued photo I.D. in order to claim their prize.

Contestant, who **guesses the correct Weight of the Ham-in-the-Freezer**, **or the Weight of the Ham Closest to the Correct Weight**, will be the winner of the 7.2 Cubic Foot **Chest Freezer & the Large Ham-in-the-Freezer**.
